

Bidfood Darwin V8s
Promotion Terms and Conditions

Information on how to enter and prize terms and conditions form part of these terms and conditions of entry.

1. This promotion begins on 7th May 2018 and ends on 1st June 2018 (“**Promotion Period**”).
2. The promoter is Fonterra Brands (Australia) Pty Ltd of Level 2, 40 River Blvd Richmond 3121, Victoria Australia (ABN 80 095 181 669) (“**Promoter**”)
3. Entry is only open to food service professionals who order the Promoter’s products via John Lewis Trading (Bidfood Darwin) 33000228231209 (“**Eligible Entrant**”).
4. Management and employees of the Promoter, its related bodies corporate, and agencies associated with this Promotion are not Eligible Entrants.
5. To enter, an Eligible Entrant must:
 - (a) Purchase a Minimum Amount of the Eligible Products across two Fonterra products from Bidfood in a single transaction during the Promotion Period;
 - (b) Complete an entry form in full;
 - (c) Return the completed entry form via a Bidfood representative; and
 - (d) retain proof of purchase for verification.
6. Only entries that comply with clause 5 are Eligible Entries.
7. Multiple Eligible Entries are permitted during the Promotion Period but each entry is subject to the requirements of clause 5.
8. The Eligible Entrant takes the risk of submitting an entry via the Bidfood representative and the Promoter is not responsible for any failure of the Bidfood representative to submit an entry.
9. At the end of the Promotion Period, a random prize draw will be conducted by Bidfood Darwin at Darwin 12 Wishart Rd, Berrimah NT 0828 on 6th June 2018 and the first 2 Eligible Entries picked will win a prize. This is not a game of skill.
10. There are a total of 2 prizes with a total value of [\$400] to be won:
 - (a) 2 prizes of a pair of tickets to the Crownbet Darwin Triple Crown V8 event between 15 and 17 June 2018 worth \$200 per pair, \$100 per ticket.
11. Prizes are subject to terms and conditions and are not transferrable or exchangeable.
12. If a prize is unavailable for any reason, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification, subject to any written directions from the relevant regulatory authorities.
13. The Promoter accepts no responsibility for any tax liabilities that may arise from claiming or receiving the benefit of a prize.
14. Prize winners are solely responsible for any additional or incidental costs in relation to the Prize including without limitation, travel, accommodation, insurance and other costs.
15. Contacts of provisional winners will be notified with three business days of the conclusion of the promotion by telephone call from a Promoter’s representative. The provisional prize winners may be asked to provide the relevant proof of purchase, connected with the winning Eligible Entry, within three business days of the date of the notification. Failure to provide the proof of purchase in the time requested by the Promoter will result in the provisional winner forfeiting the prize. Provisional prize winners will only be deemed winners once verified by the Promoter in its absolute discretion.
16. The Promoter reserves the right, at any time, to verify and request proof of the validity of entries and entrants (including a Contact’s s identity, age and place of residence and/or employment) and to disqualify any entrant or

Contact who, in the reasonable opinion of the Promoter, submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.

17. If there is a dispute as to the identity of an entrant or Contact, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant who is to be awarded a prize. If more than one person attempts to claim a prize, the Promoter has sole and absolute discretion to determine which of those persons has the rightful claim to the prize.
18. Prizes will be distributed to winners with verified proof of purchase within seven business days of the draw date by a nominated Promoter representative. In the alternative, prizes may be despatched via registered mail, addressed to the winner.
19. The Promoter accepts no responsibility for any prize that is lost, stolen or tampered with in any way. Prizes sent via registered mail to the winner discharges the Promoter's liability to award the prize to the winner.
